Reports

President

President's report to annual general meeting 16 November 2011 which was accepted.

I thank all the members of the Federation council for the insights and expertise they have bought to us, and all the work and they have done on behalf of the bushwalkers of Western Australia. I specifically thank those who have not been nominated by their Clubs as delegates but have answered the call of the Federation to serve as co-opted members. We should be especially grateful for the work of Ralph Ditton (Secretary) Pete Hegarty (OWA and insurance), Jac Considine (Environment) and Dave Osborne (access - in its broadest sense).

I also want to thank Jackie for her sterling work as Treasurer.

The Federation council has worked to raise the profile of bushwalkers and bushwalking, and to get the ear of bushwalking land managers and regulators. We attend conferences and symposiums, we sit on boards and reference panels and trails groups, we write emails and letters, we join other peak bodies and we use every opportunity to productively push our point of view on behalf of all bushwalking. We ally with other groups when appropriate and in our interests to do so. It includes seizing the opportunity to meet with the right people when the opportunity arises. (This year I and others have bush walked with the Minister for DEC and Water, with a group from DEC and DSR, and a group from DSR.) It includes the volunteer recognition activities Mel has organised. It includes the production of suitable posters and advertising material, also that Mel is doing. We nominated one of our member clubs for an outdoors



recreation industry award, based on material they had supplied in their quarterly reports. Ideally we would be able to do the same for the Federation as a whole– those quarterly reports can be very useful so keep them coming. We must continue to champion our own activities, because we are the best placed to do it and I thank all of you who are doing this.

We have had some successes, and some continuing successes in this last year:

- We have agreed on a strategic plan. This is now on our website,
- The State Trails Strategy continues to influence Government. It recognises that 'trails' include AS 2156 Class 5 and 6 unmarked routes across substantially unmodified terrain. It includes funding for research on 'right to roam', and I thank Action Outdoors Association for hosting a meeting in October to allow the Federation to hear of the right to roam work, and to influence its future direction. I hope that this work will help identify and reduce the number of impediments placed in front of walkers. Such things as trail head provision and maintenance, maps, trail maintenance, water points and vehicular access spring to mind.
- Debate on the applicability of Adventure Activity Standards to our activities continues and I thank
 Peter Hegarty for the work he has been doing with Outdoors Western Australia on this.
- Subsequent to work funded by the DSR that established that departments other than the DoW and Water Corporation had statutory authority in water catchments, and a Legislative Council committee hearing into catchment access (to which many of our member clubs and individual bushwalkers made submissions, and before which Mel and I appeared) there is a cross departmental committee from DSR, DEC, Health, DoW and Water Corporation to devise a joint response to Government on recreation in water catchments and a new Policy 13.
- The Federation has for at least ten years been pressing for water points to be established within the Fitzgerald River National Park so that the coastal traverse can be made safer and more accessible. We were very pleased when the Premier announced the construction of a Trans Fitzgerald River Walk Trail. Unfortunately there are prevailing allegations that the trail will enhance the spread of dieback. There are counter claims, which we support, that there is now foot traffic along the coastal route (and has been for many years) that potentially spread dieback, and a constructed trail will allow water points to be constructed, and management to better hinder dieback spread than is currently the case. The track is being re-designed to meet the environmental objections, and hopefully construction will proceed.
- The Federation circulated a set of risk management guidelines to all member clubs that had been ratified by Bushwalking Australia Inc.
- We continue to make a good first impression with our website. This website is maintained and updated by Hecate Jay, who is a professional website designer. We get charged for some of the work, but a huge amount of work is donated. We all owe Hecate a huge thank you for this.
- There are some unresolved issues:
- It is well know that there is only one opportunity to make a good first impression. Those of us who liaise with other groups are aware that our current name was appropriate for the era in which it was created and shows us to be anchored in that era. Consequently we need to make lots of good subsequent impressions. Our current council consists of two delegates from each member club. Unfortunately too many of our member clubs cannot find two of their members who are interested in the bigger picture for bushwalkers and bushwalking to serve as delegates. Thus we have coopted members doing work that should be done by delegates. This is undesirable. We need to agree on a new name and a new constitution that allows our member clubs to elect suitably qualified people from any and all of our clubs to make up a Board of Management. This will alter the way we work and we need a substantial majority of current delegates to accept this. Despite a lot of work by Colin Berry, and input from several delegates we have not yet been able to produce a document to present at the ΔGM
- We are facing the situation where the mining industry will roll over much of our favourite bushwalking country within less than a generation. We are already losing ground – so it has already started. The miners are charged with rehabilitating the country and are currently driven by encouraging biodiversity. Unfortunately for us, the pock marked surface that encourages biodiversity will take

- many years to settle down to a surface that will be pleasant for class five and six routes. We need to much better understand the threat and devise (and agree on) an appropriate course of action.
- Mel and I conducted an email 'debate', assisted and encouraged by Mike Wood of the Bibbulmun Track Foundation to encourage DEC to upgrade facilities and provide some signage at Sullivan Rock, in view of the extra traffic it was getting. This traffic resulted from it being the trailhead for popular loop walks using the Bibbulmun Track northwards to access the three mountains Vincent, Cuthbert and Randal; and southwards to Mount Cooke; and informal trails both east and west. We were thwarted by the lack of 'corporateness' (to coin a word) of DEC with decisions on the area being made in their Jarrahdale office independent of accepted good practice regarding vandalism in other parts of Australia.

We do need to remember that most bushwalkers simply want to go for a walk, and are very reluctant to engage in conflict. We also need to remember that almost all bushwalking land managers and regulators would like to encourage bushwalking, and if they place impediments in our way it is because of conflicting (and sometimes legal) other interests that prevail, or possibly a lack of understanding of our needs, or possibly budgetary considerations. If we positively and constructively engage with them we are much more likely to get a better outcome for bushwalkers.

In closing let me thank you for allowing me to be your president, however I will not be standing for reelection at the forthcoming annual general meeting.

Insurance Convenor Report

Federation of WA Bushwalkers - AGM 15 November 2011

Club Insurance for 2011-2012

All 9 member clubs plus the Federation have adopted BAI insurance coverage again for the year 2011 - 2012.

All payments were received on time, and the payment to the Insurers was made before the stipulated date of 20 August 2011. Congratulations to all involved from all clubs.

Numbers insured for 2011-12 totalled **982 for Public Liability** (100% of membership) and **914 for Personal Accident** (93% of membership). Total amount collected for insurance was \$9,936.00, with an additional \$1473.00 collected for levies.

Some minor policy changes have been made since last year, mainly involving overseas activities, and this was well circulated at the end of 2010.

Policy wordings, and a summary letter highlighting changes are available.

There are several risk management processes that clubs should ensure they now have in place:

- Clubs should now all have adopted an **annual "Acknowledgement of Risk" waiver** that members sign once per year, instead of the traditional walk waiver signed for each activity.
- Clubs should have a **documented Risk Management Policy** that includes clear guidelines as to who is responsible for each step, and is available to all members.
- Clubs should have a reporting system for accidents and near misses and have a formal review process for these reports
- Clubs should have **an audit process** in place to review their Risk Management Procedures to ensure they remain effective.

Members are again reminded that it is imperative to advise the Federation in the event of any

insurance claim, and "near miss" events should be included in the regular club quarterly reports to the Federation. This is the only way we can monitor the effectiveness of club programmes.
